OBTAINING A NEW POLICY

Take out a new policy for which the Festival is the owner and beneficiary.

TRANSFERRING AN EXISTING POLICY

Hand over ownership of a policy that you own and name the Festival as the beneficiary.

ADVANTAGES

- Receive a tax receipt each year in the amount of the premiums paid.
- Immediately upon the expiration of the policy, receive a tax receipt corresponding to its market value.
- Reduce the taxes to be paid on your estate.
- Leverage a powerful philanthropic tool.
